#### Joint Commitment to End All Forms of Gender Based Violence

The Heads of State and Government will gather for the United Nations General Assembly high-level week in September 2023 at the United Nations Headquarters in New York for the 2023 SDG summit. Its purpose is to provide high-level guidance to the target year of the 2030 Agenda-Sustainable Development Goals (SDGs). The 17 SDGs are not going well due to the waves of Covid-19. Additionally, the 5<sup>th</sup> SDG, will not be achieved by 2030 but another 286 years.

The 5<sup>th</sup> SDG, gender equality, is not only off track but reversed since Covid-19.<sup>4</sup> 30% of women around the world have experienced both partner violence and non-partner sexual violence, that is 760 million women globally.<sup>5</sup> Further, the UN's largest annual gathering on gender equality, also raised the concern about offline and online violence against women and girls.<sup>6</sup>

In Cambodia, even if the pandemic lockdown was a short period, online abuse has been noticed and was found mostly on a social media platform called Facebook. Many types of online violence have been reported by women and homosexuals such as un-consent filmed sexual intercourse, intimate photograph threats, cultural discrimination, and sexual harassment by being a gay man. Following the survey from Cambodia League for the Promotion and Defense of Human Rights (LICADHO) of 718 people, 38% of respondents with 20% women said to have been sexually harassed online. 8

Generally, a victim of online violence can be happening to both sexes; but more with women and girls. Although it seems to be targeted online, it can result in the suffering of physical, sexual, psychological, or economic harm. The major health problems for women including physical, mental, and sexual are caused by intimate partner violence and sexual violence, which may lead to unintended pregnancy and abortion. Moreover, it may affect children's conduct later in life by witnessing such violence within the family. It also impacts social and economic costs when women are injured from the violence, and cannot hence take care of themselves and their children. Overall, violence against women is preventable. We also see its evidence growing framework called "RESPECT Women" was published in 2019 by WHO, UN Women, and the other 12 UN and bilateral agencies to prevent violence against women.
